I and/or we acknowledge and agree that in the event of a lawsuit initiated to collect this account, suit will be in Lee County, Florida. Authorization is further given to make inquiries to trade references, financial institutions, and other parties to determine credit worthiness of Applicant.

This is a continuing and irrevocable guaranty and shall remain in full force and effect and apply to all present and future amounts owed. House of Wu, LLC shall not be required to proceed first against the Company before resorting to the undersigned for payment.

The undersigned shall not be released or discharged from their obligations hereunder by reasons of any delay, waiver, modification, extension or amendment, to any arrangement between House of Wu, LLC and the Company.
